RoHS Compliance 2011/65/EU and Directive 2015/863/EU of the European Parliament

The European Directive 2011/65/EU regulates requirements for pollutants in electrical and electronic devices. Accordingly, no articles may be imported into or traded within the European Community that do not comply with these requirements. We confirm, based on the information provided by our suppliers, compliance with the RoHS Directive according to 2011/65/EU. As far as we are aware, there are no official certificates for RoHS compliance. The following elements are either not present or only present in very low quantities (0.1%, 0.01% for cadmium by weight percent based on homogeneous materials).

- Lead
- Cadmium
- Hexavalent Chromium
- Polybrominated Biphenyls (PBB)
- Polybrominated Diphenyl Ethers (PBDE)
- Mercury

Additionally, we comply with Directive 2015/863/EU and, therefore, adhere to the updated changes to Annex II regarding the limits of added plasticizers. The following elements are either not present or only present in very low quantities (0.1%).

- Bis(2-ethylhexyl)phthalat (DEHP)
- Butylbenzylphthalat (BBP)
- Dibutylphthalat (DBP)
- Diisobutylphthalat (DIBP)

Declaration of Conformity to REACH

REACH - European Regulation on the Registration, Evaluation, Authorization, and Restriction of Chemicals (Regulation (EC) No. 1907/2006)."
